Dear Reader,

As I approach the end of my Board tenure and the end of my two years as Chair, I ask in disbelief: Can two consecutive years be more different? This table shows the often volatile and always unpredictable nature of the Board's work.

What happened? The answer, in large part, is Rosaleen Clayton. Before she consented to an indefinite suspension, Ms. Clayton was a Worcester County lawyer whose practice was largely in bankruptcy court. In July 2013, a trickle of claims were filed alleging her defalcations. That trickle became a wave during fiscal year 2014 and Ms. Clayton quickly secured the dubious distinction of having more claims filed about her misappropriations than any other lawyer in Board history. That number now stands at 84 overshadowing by 62% the old record of 52.

Thanks to our expert colleagues Messrs. Baldiga, Jeffery and Morrissey, the Board understood the special fragility of clients on the brink of bankruptcy. We set as our goal the resolution of their claims post haste. By fiscal year end, we made 76 awards totaling \$113,291.00.


We thank the members of the Worcester County bar, in particular, Wendy M. Mead and David R. Chenelle, Co-Chairs of the Worcester Bar Association's Bankruptcy Section, who rapidly stepped in to ensure that all of Ms. Clayton's former clients knew about the Clients' Security Board. In many instances, Ms. Mead and Mr. Chenelle identified lawyers who were willing to immediately represent Ms. Clayton's former clients on a pro bono basis or for a substantially reduced fee. Such activities earned no headlines but did demonstrate that our profession's moral compass is in excellent working order.

One other item of good news deserves special mention. Our veteran assistant counsel, Karen O'Toole was recently appointed to serve on the ABA Standing Committee for Client Protection. This manifests the high regard the national client protection leadership has for Karen, in particular, and for the Massachusetts program, in general.

As I end my term on the Board, I would like to thank the Board's counsel and staff for their tireless efforts to achieve the highest standards, and my fellow Board members for their generous contributions of time and talents. It has been a true privilege to serve on the Board, and I am proud of our many accomplishments in furtherance of its important mission.

In closing, my Board colleagues and I send our very best wishes to Chief Justice Roderick L. Ireland on his retirement from a distinguished tenure on the Supreme Judicial Court. We are especially grateful to Justice Ireland for his unwavering support of the mission of the Board. I know my successors look forward to working with Chief Justice Ralph D. Gants to insure that the Massachusetts client protection program continues its position of national preeminence in discharging "the collective professional responsibility of the members of the Massachusetts bar."

Claims Activity Chart 1975-2014

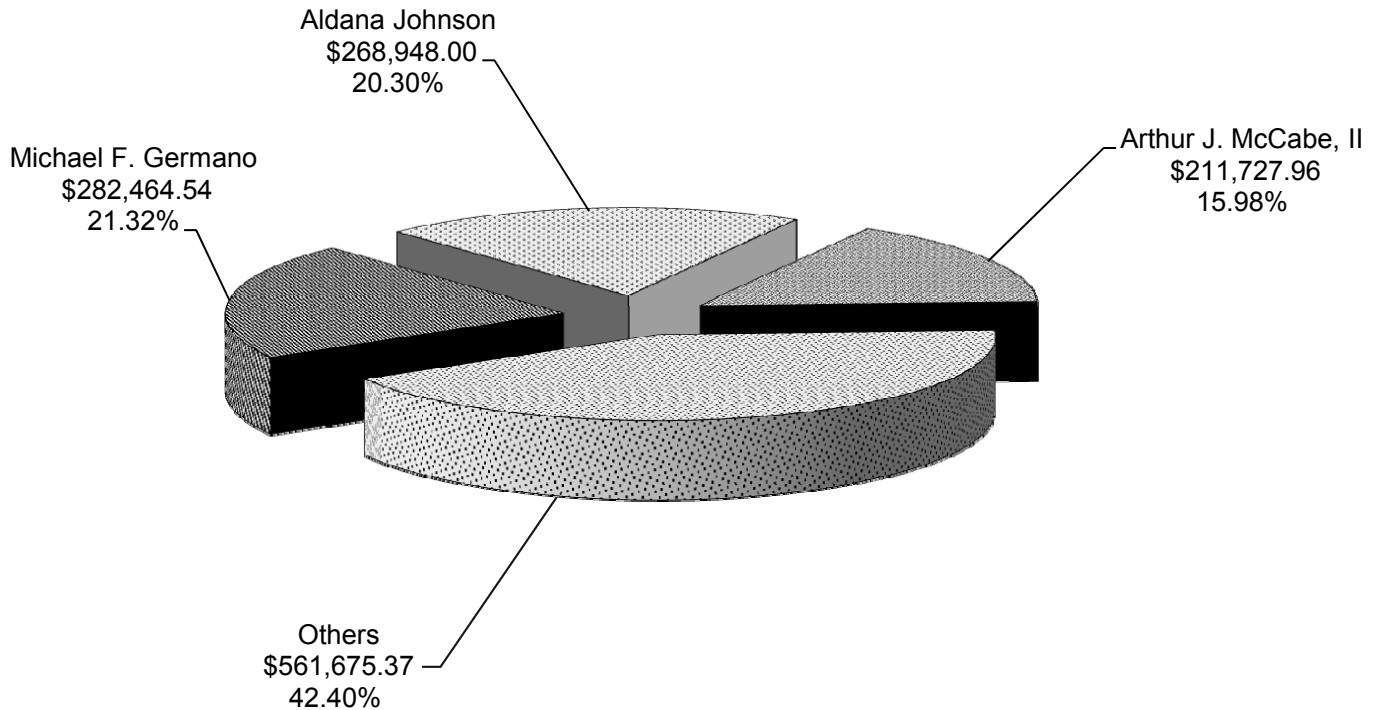

Board Members

Michelle M. Porter, Esq., Chair, was appointed to the Board on March 1, 2010. She is a Director in the Private Client and Trust Group of Goulston & Storrs whose practice is focused on estate and tax planning, trust and estate administration and charitable giving. 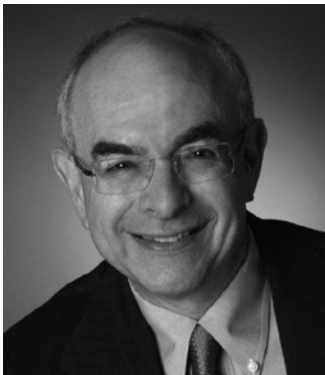
